he Integrated Health and Social Services University Network for West-Central Montreal's university mission in social gerontology is carried out by the Centre for Research and Expertise in Social Gerontology (CREGÉS). This mission is focused on leading research projects, developing and testing leading practices, participating in university teaching, offering training to Health and Social Service Network's professionals and facilitating knowledge sharing and exchange of developed expertises.

To fulfill this mission, CREGÉS counts on the participation and support of university and institutional researchers, research-practitioners, students, as well as collaborators from practice settings and partner organizations. They are supported by a team of professionals who coordinate CREGÉS's activities, carry out evaluative research and studies, and conduct a knowledge transfer and mobilization program.



SUPPORT FOR RESEARCH ACTIVITIES

SCHOLARCHIP GRANTS

To encourage social gerontology research, CREGÉS offers scholarships to students supervised by its regular members. A total of **\$16,000** was awarded during the year.

SEED GRANTS FOR COLLABORATIVE RESEARCH PROJECTS

CREGÉS provides funds for new collaborative projects between its members. An amount of **\$5,000** was granted for one project.

KNOWLEDGE TRANFER AND DISSIMINATION GRANTS

CREGÉS offers its regular members and their students financial assistance for the dissemination and sharing of research results. This year, 14 members received funding.



CONTRIBUTIONS TO PUBLIC PROGRAMS AND POLICIES

HEALTH AND SOCIAL SERVICE MINISTRY (MSSS) MANDATES

CREGÉS continued its involvement in the realization of MSSS mandates granted to the CIUSSS:

- Policy framework to counter the mistreatment of older adults and other persons of full age in vulnerable situations;
- Training on older adult mistreatment for health and social services practitioners and the community sector;
- → Training on older adult mistreatment for the financial sector;
- Profile of the services and support measures in place for caregivers in Quebec, Canada and internationally.

A new ministerial agreement was also added in 2019–2020:

→ Training on the realities and needs faced by LGBT older adults

NOWLEDGE TRANSFER AND DISSEMINATION ACTIVITIES

CREGÉS is committed to bridging the gap between research and practice through strategies that make knowledge readily available to different target groups, such as practitioners and managers within the health and social services network (RSSS), community partners, or students in social gerontology.

The ultimate goal of these strategies—
which include **publishing research results** and organizing specific **knowledge transfer and dissemination activities**—is to improve practices.

PUBLIC POLICIES

CREGÉS has contributed to the development of several national policies and laws through consultations, presentations and participation in expert committees:

- Presentations and consultations for the development of the National Policy for Caregivers
- Consultations for the development of a Long-Term Care Policy
- → Participation in the Commission on Medical Assistance for Dying and End-of-Life Care
- Participation in the sub-committee of the Ministry of Health and Social Services on the impact of population changes on health services
